SUB: - APPEAL TO HELP ODISHA STATE.

Dear Sir/Madam,

This is in continuation of our earlier request (Copy of NHQ Circular No. 38/2019, dated 06th May, 2019) for supporting the FANI Cyclone affected villages adopted by the Bharat Scouts and Guides with the support of our Sister Organisations.

The undersigned consulted various Agencies and have suggested for Action Plan for the Bharat Scouts and Guides. He desires that the Bharat Scouts and Guides should be seen as a 'Messenger of Peace' in the Community for which the suggestions of former senior Administrators of Government and the Chief Justice of High Court, Cuttack (Odisha) and the head of Asia-Pacific Scout Guide Fellowship. It is proposed that

1. To construct the low cost Disaster Repellent houses, the estimated cost is Rs.1.00 lakh per house.

Our suggestions is that

- a) Each State Association may sponsor atleast one or more such houses.
- b) The amount donated to the National Headquarters is exempted under section 80(G), the letter of Income Tax exemption under section 80(G) is attached with this letter.

At the National Headquarters level, International Commissioner (Scouts) is the Chief Coordinator for the relief operations and is coordinating the same.

We request all the State Chief Commissioners to kindly take up this on priority basis and encourage all district units and philanthropists of their States to contribute financially to support the "FANI Cyclone" affected people.

SUB: ORDER UNDER SECTION 80G (5)(VI) OF THE INCOME TAX ACT, 1961

On verification of the facts stated perfore me/hearing before me, I have come to the conclusion that this organization satisfies the conditions u/s 80G of the Income Tax act, 1961. The institution/Fund is granted approval subject to the following conditions:-

(i) The Donee institution shall forfeit this benefit provided under the law, if any of the conditions stated herein is not complied with/abused/whittled down or in any way violated.

(ii) This exemption is valid for the period from A.Y. 2010-11 to A.Y. 2012-13 and subject to the following conditions.

CONDITIONS:-

(i) You shall maintain your accounts regularly and also get them audited to comply with sec. 89G (5)(iv) read with section 12A(b) and 12A(c) and submit the same before the assessing officer by the due date as per section 139(1) of the Income tax Act 1961.

(ii) Every receipt issued to donor shall bear the number and date; of this order and shall state the date up to which this certificate is valid from A.Y. 2010-11 to A.Y. 2012-13

(iii) No change in the deed of the trust/association shall be affected without the due procedure of Law and its intimation shall be given immediately to this office.

(iv) The approval to the institution/fund shall apply to the donations received only if the fund/institution, established in India for charitable purpose, fulfills the conditions as laid down in section 80G(i), (ii), (iii), (iv) & (v) of the Income Tax Act 1961.

(v) This office and the assessing officer shall also be informed about the managing trustees of Manager of your Trust/Society/Non Profit Company and the places where the activities of the Trust/Institution are undertaken/likely to be undertaken to satisfy the claimed objects.

You shall file the return of income of your fund/institution as per section 139(1)/(4A)/(4C) of the Income Tax Act, 1961.
