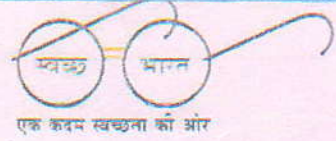

We are in the process to get license for commercial use of World Scouts Badge and being a National Association we are paying the royalty to the World Scout Bureau. All the state Associations are requested not to produce and buy World Scout Badge from except The National Headquarters.
