Action Taken Report of the Minutes of the Meeting of Rules Committee of the Bharat Scouts and Guides held on 15<sup>th</sup> September, 2018.

Agenda Item No. 1:- Confirmation of the Minutes of the last Rules Committee Meeting held at the Bharat Scouts and Guides National Headquarters, New Delhi on 19th May, 2018 and Agenda Item No. 2:- Business Arising (Action Taken Report). The minutes of the last Rules Committee Meeting held at the Bharat Scouts and Guides, National Headquarters, New Delhi on No action is required. 19th May, 2018 and Action Taken Report which have already been circulated to the members were confirmed by the house unanimously. Agenda Item No.3:- Re-consideration of Amendments to Rules, Bye-Laws, APRO-I, Memorandum of Association and Scheme of Training. The suggestions received from various States for amendments in Rules amended are Rules, Memorandum of Association, Bye-Laws were placed approved in the National Council 24/11/2019 and before the house which was discussed at length. on 29/11/2020 following due procedures. All the proposals of amendments in APRO Part-I(Annexure-A), Bye-Laws(Annexure-B), Memorandum of Association(Annexure-C), Rules(Annexure-D) and Scheme of Training(Annexure-E) were accepted with following amendments and addition: **APRO Part-I** Chapter III-2 Affiliation of State Association-To add: Annual Affiliation Fee and Individual Registration Fee. The State Association shall pay the prescribed Annual Affiliation Fee and Annual Individual Registration Fee of all the Scouts, Guides and Adults.

Chapter-IV- Recommendation of two terms continuously is not accepted.

### Memorandum of Association

Rule -7 – The National Association is a Society registered under the Societies Registration Act and is only the official organisation affiliated with the WOSM & WAGGGS to represent Scouts and Guides in India- only accepted.

Rule No. 49(a), (b) & (c) Membership to be deleted and to be made at par with the Rules.

Rule No. 4.2(b) Proposal not accepted.

Rule No. 4.2(c)- Existing Life Members of the National Association may be treated as Associate Members of the Association and to be amended as Community Scout or Friend to Scouts/Guides.

Rule No.4.3-Recommendation No.5 to be amended as follows:Provided that membership of no individual or office bearer shall
be terminated in the absence of justice and equity.
