Minutes of Combined Virtual Meeting of the National Programme Committee and National Training Committee of the Bharat Scouts and Guides held on 18th March, 2023 at 11.00 A.M.

The Combined Virtual Meeting of the National Programme Committee and National Training Committee of the Bharat Scouts and Guides was held on 18th March, 2023 at 11.00 A. M. under the chairmanship of Shri Shyamal Kumar Biswas, Hon'ble Chief Commissioner of Scouts of the Bharat Scouts and Guides.

Smt. Darshana Amar Pawaskar, Joint Director of Guides (Programme and Training) welcomed Hon'ble Chairman and all members present.

The meeting started with Scout/Guide prayer.

The members present is enclosed at Annexure-A.

Shri Amar B. Chettri, Joint Director of Scouts (Programme and Training) and Convenor welcomed the members and requested the members to stand up for one-minute silence prayer to pay homage to the departed soul of the member of this Organisation who had gone home recently.

The house stood in silence for a minute to pay homage to the departed souls.

The meeting started as per the agenda circulated to the members with the permission of the Chair.

Agenda Item No. 1: Confirmation of the Minutes of the last combined Meeting of the National Programme Committee and National Training Committee of the Bharat Scouts and Guides held at National Headquarters, New Delhi from 29th to 31st March, 2022 and Agenda Item No. 2: Business Arising (Action Taken Report).

The Minutes of the last combined Meeting of the National Programme Committee and National Training Committee of the Bharat Scouts and Guides held at National Headquarters New Delhi from 29th to 31st March 2022 and Action Taken Report were circulated to the Hon'ble members well in advance. The same were confirmed by the house unanimously as proposed by Shri G. Parameshwar, SOC(S), Telangana State BS&G and seconded by Shri Abdul A. Shaikh, STC(S), Western Railway State BS&G and Ms. Usha Chunni, SOC(G), J & K State BS&G respectively.

Agenda Item No.3: - Participation in National Level Youth Programme 2022-2023.

Shri Amar B. Chettri, Joint Director of Scouts (Prog. & Trg.) has presented the participation of State Associations in National/Regional Level Youth Programmes 2022-2023 through power point presentation. He congratulated the States having highest participation in National level Youth Programmes for the year 2022-2023 i.e. 1st Position- Madhya Pradesh and Uttar Pradesh-13 Events participation, 2nd Position- Haryana and Rajasthan-12 Events participation and 3rd Position- Eastern Railway- 10 Events participation. He requested the SOCs and STCs to ensure deputation of participants in the ensuing youth programmes at National level as well as Regional level events 2023-2024 and provide opportunity to the youth to expose themselves in constructive activities and train them for their overall development. He also emphasized the State Officials to ensure deputation of participation from their States in every events, programmes, workshop, etc organised by NHQ. Further, the convenor highlighted the name of the state whose participation is not appreciable in the event during the year with a request to look into the matter seriously.

The main achievements/highlights of the Bharat Scouts and Guides for the year 2022-2023 were presented through a power point presentation by Shri Arup Sarkar, Deputy Director of Scouts (Boy Programme). The house appreciated the same.

Agenda Item No. 4: Participation in National Adult Training Programme 2022-23.

Shri S. S. Ray, In-charge Deputy Director of Scouts, Leader Training presented the state wise participation of Adult Leaders Training Course (Scout Wing) and combined Special Course held during the year 2022-2023 through power point presentation. He briefed about the details of Courses conducted during the year i.e. HWB Courses, ALT Courses, LT Courses along with number of qualified/trained leaders, number of Parchment/Hon'ble Charge issued section wise during the year. He appreciated U.P. State for conducting 15 Courses, Chhattisgarh State for conducting 12 courses and Eastern Railway State for conducting 12 Courses during the year. He also appreciated and thanked the State Officials for deputing participants in Training Courses at NTC Pachmarhi.

Smt. Darsharna Amar Pawaskar, Joint Director of Guides (Prog. & Trg.) and Incharge Deputy Director of Guides, Leader Training also presented the Adult Leader Training Courses (Guide Wing) of the year 2022-23. She thanked all the State Training Commissioners for deputing participants in the Training Courses held at NTC, Pachmarhi

and other places. She informed that one ROT Course was organised virtually. She informed the house that due to retirement of Ms. M.N. Machamma, DDGLT, Guide Wing Courses could not be organised as required during the year at NTC.

Agenda Item No. 5:- Proposed Schedule of National and Regional Level Events 2023-24. The Convenor informed the house about the proposed Schedule of National and Regional Level Events for the year 2023-2024. He informed the house that NHQ Circular No. 25/2023, dated 13/02/2023 was circulated to all the members for confirmation and suggestions, if any on the proposed schedule but none of the members responded. Hence, it is assumed that the members do not have any suggestions and the proposed schedule for the year 2023-2024 is accepted. He further presented brief description about the proposed Regional and National Youth Programmes and activities 2023-2024, Workshops/Seminars/Training Courses at NTC, Pachmarhi, Youth Programmes for N. E. Region, Adult Training Programmes for N. E. Region as well as Adventure Programmes at different places and requested once again to go through the proposed schedule. He also appraised the house that the Bharat Scouts and Guides, National Headquarters has applied for grant-in-aid for Scouting/Guiding activities for the year 2023-24 with Ministry of Youth Affairs and Sports, Govt. of India for subsidising boarding and lodging and travelling expenses of the participants. Till grant-in-aid from Government is received, he informed that the proposed events will be organised under self-finance basis under amended budget provisions. He appealed for the support of State Associations to provide consent for hosting the events as well as deputation of participants and promotion of events. He further announced that the Bharat Scouts and Guides, National Headquarters will conduct National Integration Camp at Maharajganj, Uttar Pradesh from 26th to 30th May 2023 in which lodging and boarding will be sponsored by the host.

The house unanimously recommended the Proposed Schedule of National and Regional Level Events (Youth programme & Adult Leaders Training Programme) for the year 2023-2024 as proposed by Shri T.D. Gouri Shankar Rao, SOC(S), South Central Railway State BS&G and seconded by Shri Arvind Kumar Srivastava, STC(S), Uttar Pradesh State BS&G respectively.

Agenda Item No. 6:- Recommendations of National Youth Committee.

The Convenor informed the house that Virtual Meeting of National Youth Committee of the Bharat Scouts and Guides was held on 11/02/2023 and the Minutes of the National Youth Committee was circulated to the members well in advance. He introduced the

house that Miss Ritika Sharma from J & K State was the Chairperson and Shri Hemant Sharma from Chhattisgarh State was the Co-Chairperson of the National Youth Committee. Further, he invited the Co-Chairperson Shri Hemant Sharma to appraise the house about the recommendations of National Youth Committee. Shri Hemant Sharma, Co-Chairperson has suggested that they have not received the name of youth committee members from many of the State Associations of the Bharat Scouts and Guides as the State Associations have not constituted the State/District Youth Committee. Only 23 States have constituted the State Youth Committee and recommended the names. He also suggested that the Meeting of the National Youth Committee be organised physically instead of virtually so that we can interact to know each other and received viable suggestions during the face-to-face meeting.

The Convenor informed the house that Circular and many reminders were sent to the State Associations to constitute the Youth Committee at State as well as District level and forward the names of Chairperson and Co-Chairperson of the State Youth Committee to NHQ. He appealed the State officials to motivate the young people and constitute the Youth Committee on priority and register their names in the National Youth Committee at the earliest without any further delay. The members confirmed that they will implement the same on priority.

Agenda Item No. 7:- Updated on Online Youth Membership Registration System(OYMS).

Smt. Darshana Amar Pawaskar, Joint Director of Guides (Prog. & Trg.) appraised the house about the update on Online Youth Membership Registration System(OYMS) through power point presentation and requested the State Associations to register all Cubs/Bulbuls/Scouts/Guides/Rovers/Rangers, adult leader and volunteer leaders at the earliest. She congratulated four State Associations who have registered 100% Individual in OYMS registration i.e. 1- K.V.S. State BS&G, 2- Kerala State BS&G, 3- West Bengal State BS&G and 4- Eastern Railway State BS&G. She appealed to all the State Associations to take initiative on priority basis to register every members in OYMS portal. The process of registration was also shared through video clippings. She also informed the house that if any State Association require and sort of support in taking up the task, they may write to NHQ. NHQ will provide all necessary support as required on OYMS.

Agenda Item No.8:- Membership Growth- An Update.

Shri Sarathraj E., Project Manager, BS&G Membership Growth Cell has presented the update on census for the year 2021-2022 and briefed about the NHQ Circulars which were issued on Census capping based on highest census of five years comparison starting from 2014 to 2019 and 1% penetration rate of school going population whichever is higher. He has also informed that the National Headquarters collects the Individual Registration Fee based on the census capping. Total six States such as Haryana, Rajasthan, Sikkim, South Western Railway and Tamilnadu State has taken the benefit on payment of IRF for the year 2021-2022. He also requested the State Associations to revive the actual census of the States and submit the same to the National Headquarters as we need to progress on the membership growth. He also requested the State Training Commissioners of both wings to submit the training report of Basic Courses starting from November 2022 to March 2023 which has been completed as well as the training plan of the Basic Course from April 2023 to March 2024 to the BS&G Membership Growth Cell so that Growth Cell can look forward to support the States in term of technical assistance as well as resource materials.

Agenda Item No.9:- Rashtrapati Award – An Update

Dr. Raj Kumar Kaushik, Director BSG updated the house about the President Scout/Guide/Rover/Ranger Certificate Examination conducted by third party testing agency on 06/08/2022 of the last four years (i.e. from 2018 to 2021). He informed that the results were sent to the Ministry of Youth Affairs and Sports, Govt. of India and expected that the results of online examination will be approved and announced shortly after the clearance from the Ministry and the President's Secretariat. The National Headquarters had recently replied to the queries of the Ministry pertaining to the online examination. He further informed the house that NHQ is stressing to approve 480 Rashtrapati Awardeess @ 120 each year in place of 120 only under the signature of the Hon'ble President of India. He also informed the house that balance certificate will be issued to eligible candidates under the signature of Hon'ble Chief National Commissioner of the Bharat Scouts and Guides. The same has been communicated to the Ministry but yet to receive confirmation. He apprised the house that these issued will be sorted out and resolved soon in favour of Scouts and Guides.

He further informed the house that on the appeal of many State Associations, National Headquarters had circulated Circular in regard to extension of the date of submission of the registration forms for the National Level President Scout/Guide/Rover/Ranger Certificate Examination for the year 2022 up to 15th March 2023 which is now already over and no further extension will be considered.

Further, he also informed the house that a petition was filed by one of the Guide of Northern Railway in the Hon'ble High Court of Delhi in regard to issue of Provisional Certificate of Rashtrapati Award and Ministry of Youth Affairs and Sports, Govt. of India and Railway Board and the National headquarters are the respondents in this Case. Hon'ble High Court has given direction to the Ministry to take suitable action in this regard at the earliest pertaining to consideration of Provisional Certificate.

Smt. Anamika Das, SOC(G), Odisha State, Miss Rooma Sapra, SOC(G), Haryana State, Shri Brajesh Kumar Ram, SOC(S), S. E. Railway State raised about the issue of 120 Rashtrapati Award Certificates and not holding of PMSC Rally. Smt. Anamika Das, SOC(G) of Odisha State suggested that the pending Certificates of PMSC may be distributed during the ensuing National Council Meeting. The Director replied that we are in touch with the Prime Minister's house to get the consent for the PMSC Rally.

Agenda Item No.10:- National Strategic Plan- An Update

Shri Arup Sarkar, Deputy Director of Scouts (BP) appraised the house about conduct of the National Strategic Planning Workshop held at National Headquarters, New Delhi from 11th to 15th March, 2023. He informed that 57 participants attended the workshop from 32 State Associations. He briefed about the Vision 2034 and its priority areas. Joint Director of Scouts (Prog. & Trg.) requested the State officials to start working on the Strategic Priorities as per Vision 2034. He said the National Headquarters will issue the Circular in this regard for adoption of the Vision 2034 after due approval from the appropriate committees very shortly.

Agenda Item No.11:- Any other matter with the permission of the Chair.

Preparation of National Level President Scout/Guide/Rover/Ranger Certificate

Examination questionnaires.

The Director informed the house that the National Headquarters has issued the Circular in regard to preparation of Model Questionnaires for National Level President Scout/Guide/Royer/Ranger Certificate Examination and the State

Associations are requested to nominate senior trainer's/unit leaders in preparing Model Questionnaires. He requested the State Associations to submit the hard/soft copy of standard model questions to NHQ as per the stipulated timeline i.e. 31/03/2023. Ms. Ameetha Patel, SOC (G) requested to extend timeline. Jt. Director of Scouts (Prog. & Trg.) informed that whatever is completed may be submitted by 31/03/2023 and the balance be submitted by 15/04/2023.

(ii) Preparation of Bharat Scouts and Guides Questionnaires Handbook.

After a brief discussion, All the State Associations agreed a Questionnaires Hand Book on preparing for Rashtrapati Test. All the State assured to submit model questionnaires to NHQ. The Director requested the State Associations to extend their support and cooperation to complete the Questionnaires Handbook in time.

(iii) Suggestions on Uniform

Joint Director of Guides (Prog. & Trg.) informed the house about the approvals in the change in Uniform. Dr. Raj Kumar Kaushik, Director BSG informed that the uniforms are prepared and worn as an experimental basis during the 18th National Jamboree of the Bharat Scouts and Guides held at Rohat, Pali, Rajasthan from 04th to 10th January 2023 but the same is not liked by the many members especially the youth. The matter of uniform were also discussed during the Youth Forum in the 18th National Jamboree. The recommendations of Youth Forum was 'One Nation, One Colour' which was shared through power point presentation with suggestions. Joint Director of Guides (Prog. & Trg.) After a lengthy discussion, it has come to conclusion that every States have to send selected two set of sample uniform one for Scout Wing and one for Guide Wing to the National Headquarters for finalisation. Hon'ble Chief National Commissioner is authorised by the house to constitute a Committee at National level to finalise the Uniform.

The house agreed with the proposal as proposed by Shri Abdul A. Shaikh, STC(S) of Western Railway State and seconded by Shri T. D. Gouri Shankar Rao, SOC(S), S. C. Railway State BS&G and seconded by Smt. Kamini Shrivastava, SOC (G), Uttar Pradesh State BS&G and Ms. Sunita Maungkoi, STC(G), NVS State BS&G and Mrs. Chandrakanta Upadhyay, SOC(G) M.P. State BSG respectively.

(iv) Disaster Management Project

Shri Arup Sarkar, Deputy Director of Scouts(BP) informed the house about the Disaster Management Project to be taken up by the Bharat Scouts and Guides with the support of the National Disaster Management Authority, Govt. of India, He requested the State Associations to send the name of Rovers and Rangers who are willing to work in this project.

Shri A. K. Shrivastava, STC(S) of Uttar Pradesh State informed that 50 persons are already trained in Disaster Management at Bulandsahar, Bijnor and Lucknow with the assistance of Govt. of India Disaster Management Cell.

Further, in continuation with the agenda under any other matter, Joint Director of Scouts requested the State Associations to constitute Adult Resource Management Committee at State & District level and implement Adults in Scouting/Guiding Policy already approved and circulated. He informed that the National Headquarters will conduct one National Level Capacity Building Workshop on Adults in Scouting/Guiding Policy at NTC, Pachmarhi tentatively from 07th to 11th May 2023 in which State Secretaries and STCs and State Commissioners for Adult Resources will be invited to participate focussing on the 12 focal States under membership growth project. Further similar echo workshops will be organised at the regional level.

(V) BSG Social Media

The Director informed the house about the youtube channel of BS&G, facebook, Instagram, BS&G News Channel and requested the members to motivate their Scouts/Guides/Rovers/Rangers to use these BSG Social Media for promotion and visibility of the organisation. He also requested the State Associations to clear their long pending dues of IRF, Flag Day dues and Supply Service Department dues of the National Headquarters.

Address by the Chairperson of the Meeting Shri S. K. Biswas, Chief Commissioner of **Scouts**

Shri S. K. Biswas, Chief Commissioner of Scouts and the Chairman of the meeting delivered a closing remarks and thanked all the State Associations present and participated actively in the deliberations and discussed in different aspects of the agenda. He appreciated their valuable suggestions during the last three hours virtual meeting of National Programme and Training Committee. He encouraged all the SOCs and STCs to work hard, formulate the programmes of the Committee and achieve the target of the Bharat Scouts and Guides' He also congratulated the States for good participation in National as well as Regional Events and appreciated the 100% OYMS registration States. He also stressed that more adult leaders training (Guide Wing) should be organised and conducted at NTC. The meeting ended with vote of thanks to the Chair by Shri Arup Sarkar, Deputy Director of Scouts (Boy Programme) followed by National Anthem.
