73rd Ordinary Annual General Meeting of the National Council of the Bharat Scouts and Guides was held physically as well as virtually on 26th November, 2023 at 11.00 A. M. under the chairmanship of Dr. Anil Kumar Jain, Hon'ble President of the Bharat Scouts and Guides.

The meeting started with Scout/Guide Prayer.

Shri Raj Kumar Kaushik, Director welcomed Hon'ble President, Vice-Presidents, Chief National Commissioner and all members present in the National Council Meeting.

He also introduced Shri CSR Ram, IFS, Joint Secretary (BIMSTEC, SAARC), Ministry of External Affairs, Govt. of India, New Delhi appointed as National Advisor (International Affairs) of the Bharat Scouts and Guides and Smt. Sujata Chaudhry, I. Po. S. (Retd.), Former Chief Post Master General, Jharkhand appointed as National Commissioner (Headquarters) for Special Programme- (Guide Wing) of the Bharat Scouts and Guides.

Address by Hon'ble President, The Bharat Scouts and Guides

Hon'ble President, The Bharat Scouts and Guides in his presidential address extended heartfelt appreciation and gratitude to all the members who dedicated their valuable time to participate in this meeting physically as well as virtually. He mentioned that The Bharat Scouts and Guides hold a prestigious position as one of the oldest and largest movement in India with a history dating back to pre-independence decades. The current structure of our organisation has evolved over years of national level meetings shaping its present form. He appreciated the positive feedback, valuable suggestions presented during the deliberations from most of the members. He encouraged all members to continue sharing their aspirations for the improvement of the movement. He express gratitude for their dedication, enthusiasm and support. The success of this Annual General Meeting is attributed to your valuable presence and active participation. He further stressed the members to support in reaching the census target set for one crore by the end of 2025.

The main achievements of the Bharat Scouts and Guides during the last one year were presented through a power point presentation by Mrs. Darshana Pawaskar, Jt. Director(SS).

The results of various Award Competitions and G. Ranga Rao Award for the period 2022-2023 were announced (**Annexure-B**) by Mr. Amar B. Chettri, Jt. Director of Scouts(Prog. & Trg). The G. Ranga Rao Award for the year 2023 is conferred to Shri Krishnaswamy R., Former Executive Director, Shri Moti Lal Sharma, Cook and Shri Swami Das, Watchman cum Mali. Shri Moti Lal Sharma, Cook received the award physically from the gracious hand of Hon'ble President of the Bharat Scouts and Guides. Shri Swami Das joined online to receive the Award. Further, the house congratulated the winning State Associations for various award during the year 2022-2023 as well as the team for their efforts.

The Director invited Shri Manoj Mittal, CEO, Alumni Management Company, Shri Pawan Agarwal, CEO, Food Future Foundation and Shri CSR Ram, IFS, to introduce themselves and present their views and suggestions for the growth and development of the Bharat Scouts and Guides in the National Council meeting.



The Meeting started as per Agenda items.

Agenda Item No. 1: Confirmation of the Minutes of the last National Council Meeting held on 27th November, 2022 and Agenda Item No. 2: Business Arising (Action Taken Report).

The Minute of the last National Council Meeting of the Bharat Scouts and Guides held virtually on 27/11/2022 and Action Taken Report were sent to the Hon'ble members well in advance. The same were confirmed by the house as proposed by Dr. K. P. Mishra, Senior Vice- President of the Bharat Scouts and Guides and seconded by Shri Ravindra Mohan Kala, National Advisor for Administration of the Bharat Scouts and Guides.

Agenda Item No. 3: Consideration and adoption of the Annual Report for the year 2022-2023.

The Annual Report of the Bharat Scouts and Guides for the year 2022-2023 in English and Hindi languages was sent to the Hon'ble members well in advance as recommended by the National Executive Committee in its meeting held on 14/10/2023. The same was appreciated and confirmed by the house as proposed by Dr. M. V. C. Varalaxmi, State Secretary of Telangana State Bharat Scouts and Guides and seconded by Smt. Manjula Singh, SOC(G) of Delhi State Bharat Scouts and Guides respectively.

Agenda Item No. 4: Consideration and adoption of the Audited Statement of Accounts and Balance Sheet for the year 2022-2023.

The Audited Statement of Accounts and Balance Sheet for the year 2022-2023 as recommended by the National Executive Committee held on 14/10/2023 and was circulated to the Hon'ble members well in advance along with meeting notice. Dr. K. P. Mishra, Vice President, Bharat Scouts and Guides enquired about Shri Alok Goel, National Treasurer of the Bharat Scouts and Guides. The Director replied that Shri Alok Goel, National Treasurer is out of station and he is attending the meeting online. The Audited Statement and Balance sheet was confirmed by the house as proposed by Shri G. Swamy, National Commissioner (Headquarters) for NTC and seconded by Smt. Manjula Singh, SOC(G), Delhi State Bharat Scouts and Guides and Dr. K. P. Mishra, SCC & Vice-President of the Bharat Scouts and Guides.

Agenda Item No. 5: Consideration and approval of the revised Budget for the year 2023-2024 and Budget Estimate for the year 2024-2025.

The Revised Budget for the year 2023-2024 and Budget Estimate for the year 2024-2025 as recommended by the National Executive Committee held on 14/10/2023 and was circulated to the Hon'ble members well in advance along with meeting notice.



Dr. K. P. Mishra, Vice President wanted to know about revised budget 2024-2025. Hon'ble Chief National Commissioner explained in detail. The house agreed with the same.

Hon'ble Chief National Commissioner informed the house about the difference between the financial policy and fiscal policy as raised by Mr. M.A. Khalid, SC(S) & ACNC during the meeting. After a lengthy discussion, the same was approved by the house as proposed by Shri G. Swamy, National Commissioner (Headquarters) for NTC and seconded by Shri Shyamal Kumar Biswas, SC(S) & Chief Commissioner of Scouts of the Bharat Scouts and Guides.

Further, Shri P.G.R. Sindhia, State Chief Commissioner, Karnataka State suggested that the office bearers of the Bharat Scouts and Guides should contribute from their resources at least Rs. 10 Lakhs per member to the National Headquarters. In this regard, Dr. Anil Kumar Jain, Hon'ble President appreciated the proposal of Shri P.G. R. Sindhia ji and suggested that a man like Sindhia ji should initiate and contribute Rs. 50 Lakhs for the development of the National Headquarters. Hon'ble President also informed the house that he and Khandelwal ji will ensure contribution of Rs.50.00 Lakhs each i.e. One Crore from well-wishers for the welfare of the National Headquarters.

Agenda Item No. 6: Consideration of resolutions and subjects of which requisite Notice has been given and which are admitted by the President (Refer Rule 12.8.6).

No such resolutions have been received from any members.

Agenda Item No. 7: Consideration of such matters as have been tabled by the National Executive Committee and included in the Agenda (Refer Rule 12.8.7).

The Director informed the house that the Meeting of National Executive Committee held physically as well as virtually on 14/10/2023, Meeting of National Finance Committee held physically as well as virtually on 08/10/2023 respectively and the Minutes of both the meetings were sent to the Hon'ble members well in advance. He also informed that the National Executive Committee in its meeting held on 14/10/2023 has recommended for slight modification and amendments in Rules of the Bharat Scouts and Guides Rule No. (17.9.23.5) and Rule No. (17.9.23.7) under Agenda Item No. 7.

- (i) **To delete the following sentences "The State Executive Committee" from the Rules Book Rule No. (17.9.23.5) as there is no provision of election of the State Executive Committee, hence to avoid confusion; it is proposed to delete this sentence.**



- (ii) **To be added at Rule No. (17.9.23.7)- "In case of dispute regarding State Council members when the State Council is dissolved, direct Administrator or any person to call all the warranted Scouters/Guiders as member of Adhoc Council to approve State Bye-Laws and elect President, Vice Presidents and State Chief Commissioner."**

Shri R. M. Kala, National Advisor for Administration suggested regarding correction in place of "any person to call all the warranted Scouters/Guiders" as "**any person nominated by the Chief National Commissioner to call all the warranted Scouters/Guiders**".

The same was approved by the house as proposed by Shri G. Parameshwar, SOC(S), Telangana State Bharat Scouts and Guides and seconded by Ms. Sheela Joseph, SOC(G), Kerala State Bharat Scouts and Guides respectively.

Agenda Item No. 8: Consideration of matters not included in the Agenda but which are brought before the National Council with the permission of the President (Refer Rule 12.8.8 of the Rules).

No such matters have been received from any members for discussion under this Agenda Item.

Agenda Item No.9: Consideration of the appointment of Auditors and fixing their remuneration.

The Director informed the house that present Auditor M/S Thakur, Vaidyanath Aiyar & Co., Chartered Accountants, 221-223, Deen Dayal Marg, New Delhi-110002 are working smoothly on accounts. He informed the house that no complaint is received, hence the present Auditor may continue and the house agreed with the proposal for re-appointing the same firm as the Auditors of the Bharat Scouts and Guides in the existing terms and conditions. The house agreed with the same and confirmed.

Agenda Item No. 10: Consideration of amendments made in the Rules recommended by National Executive Committee in its meeting held on 14/10/2023.

The Director informed the house about the amendments made in Rules recommended by the National Executive Committee were approved by the house unanimously. The Amendments in Rules as mentioned under the Agenda Item No. 10 is enclosed at **Annexure-C**.

Agenda Item No. 11: Any other matter with the permission of the Chair.

- (i) **Consideration of Schedule of Events- 2024-2025**

The Schedule of Events of the Bharat Scouts and Guides for the year 2024-2025 was sent to the Hon'ble members well in advance. The same was accepted by the house unanimously.



(ii) **Deployment of Secretary to the office of Chief National Commissioner and Director Special Programmes, Bharat Scouts and Guides, India.**

The Director explained the house about the need of deployment of Mr. S Prassanna Shrivastava, Director Global Development, APR, WOSM. Mr. Kala, State Secretary, Uttarakhand and National Advisor for Administration proposed that it is an administrative matter and it cannot be decided by the voting. Hon'ble Chief National Commissioner can take suitable decision in this regard. The house approved taking services of Shri S. Prassanna Shrivastava on deputation for a period of one year in the beginning as per the proposal.

(iii) **Vision-2034**

The Vision -2034 was placed during the meeting as recommended by the National Executive Committee in its meeting held on 01/07/2023 and 14/10/2023 for confirmation. After a lengthy discussion, Hon'ble Chairman suggested that Vision-2034 may be changed as Vision- 2027(short term plan) in consultation with the Chief National Commissioner and the house agreed with the proposal unanimously as suggested by the Hon'ble Chairman.

(iv) **Amendment in The Bharat Scouts and Guides Logo.**

The Director informed the house that the Branding of the Bharat Scouts and Guides has already approved in the last National Council Meeting held on 27/11/2022 and minor amendment on the branding of the **Bharat Scouts and Guides branding logo** by adding "since 1908". Hon'ble Chief National Commissioner clarified the slight amendments. The house approved the **Bharat Scouts and Guides branding logo** for use in the Branding unanimously.

Shri P. G. R. Sindhia, Secretary General, President-in-Council of the Bharat Scouts and Guides thanked NHQ for proposing Bengaluru as the Headquarter for Air Scouts and Guides. He said that all support will be provided to NHQ in promoting Air Scouts and Guides with the coordination of Hindustan Aeronautical Limited (HAL), Bengaluru. He further appealed to the Hon'ble Chief National Commissioner to provide Sea Scout and Guide Headquarters at Bengaluru itself so that both the special branches i.e. Air Scouting and Guiding and Sea Scouting and Guiding can be developed in the Country under the supervision of the National Headquarters. He assured to made all arrangements of its office and infrastructure. He congratulated the Chief National Commissioner, Director and his NHQ team for the splendiferous performance under the guidance of Dr. K.K. Khandelwal, CNC.

He also informed that Captain Pranjal of Karnataka State who was Rajya Puraskar Scout laid down his life in sacrificing for the Nation at Jammu and Kashmir recently and requested the Hon'ble President to launch any scheme or programme at National/Regional level on his memory. Dr. Anil Kumar Jain, Hon'ble President assured that the proposal will be considered.

Many members informed about the Hindustan Scouts and Guides Association disturbing Scouting/Guiding activities and misguide the young people in different way. Hon'ble Chief National Commissioner apprised the house about the action to resolve the issue of Parallel Organisation. Ms. Tusha Chawla, Legal Consultant also informed the house about the status. Further, Hon'ble Chief National Commissioner also informed the house about the Act on using Emblem and Name and its improper use. He informed that Scout Logo is protected under copy right act and legal action to be taken for its mis-use. Dr. Anil Kumar Jain, Hon'ble President informed the house that he will discuss the matter with the Hon'ble Minister of Youth Affairs and Sports and Hon'ble Prime Minister of India in this regard. He said that Bharat Scouts and Guides is a legal organisation and only one organisation of Scouts and Guides will function in India.

Shri Kailash Kumar Soni, State Secretary, Chhattisgarh State BS&G, Ms. Manjula, SOC(G), Delhi State BS&G, Shri R.P. Kotwal, STC(S), J & K State BS&G enquired about the dual membership related to BS&G and ISGF. Smt. Seema Rathi, Secretary General of ISGF has informed about the activities and services going on in ISGF and informed that uniform members are also member. She informed that the Bharat Scouts and Guides has not issued Charter to ISGF till date. The Director informed the house that we have issued letter and reminders to the ISGF for payment of Affiliation fee but inspite of more than 3 years, ISGF has not paid the amount. Hon'ble Chief National Commissioner informed the house that agreement with ISGF was made not to entertain our young people from the age group of 5 to 25 years and warranted adult leaders and trainers. Ms. Seema informed that they do not want to be affiliated as the ISGF is an independent organisation. Further, Hon'ble Chief National Commissioner informed that he will discuss the matter with Justice Kalpesh Jhaveri in this regard. Dr. Anil Kumar Jain, Hon'ble President said that dual membership will not be accepted. He suggested that a meeting may be called with Hon'ble Chief National Commissioner, Shri P.G.R. Sindhia, Dr. K. P. Mishra and Shri M. A. Khalid and recommend suitable suggestions in this regard.

Hon'ble President has launched the Service Star Badge of the Bharat Scouts and Guides and the house applause.

The Chief National Commissioner informed the house about the importance of Flag day and contribution made for the same. He urged all the states to ensure utilisation of the Flag day for the visibility and fund raising for the development of the organisation. He also requested to pay the IRF in time as the NHQ is not interested the implement the rule 51 by debarring the state in meetings and activities.

The Chief National Commissioner also advised NHQ staff and volunteers to work as a family and team to achieve the target instead of finding faults. Dr. Khandelwal, CNC also informed the house about the dedicated work done by the NHQ staff and the Director. Mr. PGR Sindhia and Dr. K.P. Mishra also appreciated and requested Dr. Khandelwal to record the service given by Director and his team in the minutes.




Hon'ble President of the Bharat Scouts and Guides gave his blessings and congratulated all the members for their active participation and shared their valuable suggestion. He appealed the State Associations to pay the IRF dues to the National Headquarters in time as the same is mandatory for all. He also requested to clear the Supply Service dues of the National Headquarters. He appealed the members for use of NAMO App and to include Govt. of India launched programmes like, Namami Gange, Bharat Sankalp Yatra and Climate change, etc. in the Scouting and Guiding activities.

Hon'ble Chairperson thanked all the members for their active participation and valuable suggestions shared during the meeting.

The meeting ended with vote of thanks to the Chair followed by National Anthem.

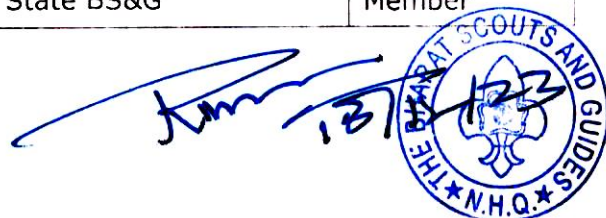
